Project abstract:

Industrial policy has re-emerged as a central instrument of economic development, yet rigorous evidence on the effectiveness of contemporary firm-level incentive schemes remains limited, particularly in emerging economies. This dissertation evaluates the causal impact of India's Production Linked Incentive (PLI) Scheme for Pharmaceuticals, a performance-based industrial policy introduced in 2020 to promote domestic manufacturing, exports, and global competitiveness. Unlike traditional input-based subsidies, the PLI scheme links government support directly to firms' incremental production and sales, making it an important case for evaluating the effectiveness of outcome-contingent industrial policy.

The analysis employs a firm-level panel dataset constructed from the CMIE Prowess database covering the period 2015-2025. The treatment group consists of pharmaceutical firms approved under the Department of Pharmaceuticals' PLI Scheme, while the control group comprises non-beneficiary pharmaceutical firms selected using pre-treatment characteristics to ensure comparability. To address non-random programme participation arising from eligibility criteria based on firm size and manufacturing capability, the study combines entropy balancing with a Difference-in-Differences research design. This approach estimates the average treatment effect of programme participation while controlling for observable pre-treatment differences and common macroeconomic shocks, including those associated with the COVID-19 period.

The dissertation examines multiple dimensions of firm performance, including total income, sales, exports, fixed asset accumulation, profitability, and investment-related outcomes, thereby capturing both the immediate and broader economic effects of the scheme. In addition, the analysis investigates heterogeneous treatment effects across firms with different pre-treatment capabilities to assess whether existing firm characteristics condition the effectiveness of industrial policy.

By providing one of the first causal firm-level evaluations of the pharmaceutical PLI scheme using quasi-experimental methods, this study contributes to the growing literature on industrial policy and firm performance in developing economies. The findings offer evidence on whether performance-linked subsidies translate into measurable improvements in firm outcomes and generate insights for the design and implementation of future industrial policy initiatives in India and other emerging markets.

Data Collection

Yes. This study relies exclusively on secondary firm-level panel data and publicly available administrative information.

The primary dataset will be obtained from the **CMIE Prowess** database, which provides audited financial and operational information for Indian companies. The dataset covers the period **2015-2025** and includes firm-level variables such as total income, sales revenue, exports, fixed assets, profitability, and other financial indicators used to measure firm performance.

Information on firms approved under the **Production Linked Incentive (PLI) Scheme for Pharmaceuticals** will be compiled from publicly available documents published by the **Department of Pharmaceuticals, Government of India**, including official lists of approved applicants and scheme guidelines. These documents will be used to identify beneficiary firms and construct the treatment variable.

All data used in the study are organisational or administrative records relating to firms rather than individuals. The research does not involve personal data, confidential information, or data from human participants. No individual-level information will be collected, processed, or analysed.
